## **Quarterly Highlights**

### **Financial** Results

- Net investment income per share of \$0.63 in Q1'24, compared to \$0.67 in Q4'23
- Earnings per share was \$0.59 in Q1'24, a decrease from \$0.70 in Q4'23
- Net asset value per share was \$20.67 as of Q1'24, unchanged from \$20.67 as of Q4'23, despite dilution from the IPO
- The Board of Directors (the "Board") declared a regular dividend of \$0.50 per share, representing an 9.7% annualized total dividend yield(1)(2)

## **Portfolio Activity**

- Total fair value was approximately \$3.3 billion, invested in 178 portfolio companies in 31 industries
  - Weighted average yield at amortized cost of debt investments was 11.9%<sup>(3)</sup>
- The Company committed \$232.1 million<sup>(4)</sup> to new investments during Q1'24
- 100.0% of new investment commitments were in floating rate first lien senior secured loans
- Invested across 9 new and 21 existing portfolio companies
- Received three full repayments during Q1'24
- Three investments on non-accrual status as of March 31, 2024; 0.4% of the portfolio at cost as of March 31, 2024

### Debt & Liquidity

- Outstanding debt balance was \$1,492.3 million, consisting of 47% unsecured debt; quarter-end debt-to-equity ratio was 0.81x
- The Company had total liquidity of \$988.5 million, including cash of \$64.8 million and undrawn, committed debt capacity of \$923.7<sup>(5)</sup> million

### Recent **Events**

- The Board declared a regular second quarter dividend of \$0.50 per share
- On April 19, 2024, the Company executed an amendment to the Truist Credit Facility, extending the maturity from January 2028 to April 2029. As part of the amendment, the total commitment was increased from \$1.12 to \$1.3 billion and pricing terms were maintained
- In late March, Fitch Ratings affirmed MSDL's BBB- (stable) rating
- 1. For the quarter ended March 31, 2024, the Company declared a regular dividend to stockholders in the amount of \$0.50 per share paid on April 25, 2024 to stockholders of record as of March 29, 2024, representing an annualized dividend yield of approximately 9.7%.
- 2. Annualized dividend yield is calculated by dividing the declared dividend by the weighted average of the net asset value at the beginning of the quarter and capital transactions during the quarter, annualized over four quarterly periods. 



### Internal Risk Rating System (1)

Risk Rating 1	In the opinion of our Investment Adviser, investments in Category 1 involve the least amount of risk relative to our initial cost basis at the time of origination or acquisition. Category 1 investments performance is above our initial underwriting expectations and the business trends and risk factors are generally favorable, which may include the performance of the portfolio company, or the likelihood of a potential exit.
Risk Rating 2	In the opinion of our Investment Adviser, investments in Category 2 involve a level of risk relative to our initial cost basis at the time of origination or acquisition. Category 2 investments are generally performing in line with our initial underwriting expectations and risk factors to ultimately recoup the cost of our principal investment are neutral to favorable. All new originated or acquired investments are initially included in Category 2.
Risk Rating 3	In the opinion of our Investment Adviser, investments in Category 3 indicate that the risk to our ability to recoup the initial cost basis at the time of origination or acquisition has increased materially since the origination or acquisition of the investment, such as declining financial performance and non-compliance with debt covenants; however, principal and interest payments are not more than 120 days past due.
Risk Rating 4	In the opinion of our Investment Adviser, investments in Category 4 involve a borrower performing substantially below expectations and indicate that the loan's risk has increased substantially since origination or acquisition. Most or all of the debt covenants are out of compliance and payments are substantially delinquent. For Category 4 investments, it is anticipated that we will not recoup our initial cost basis and may realize a substantial loss of our initial cost basis at the time of origination or acquisition upon exit.






