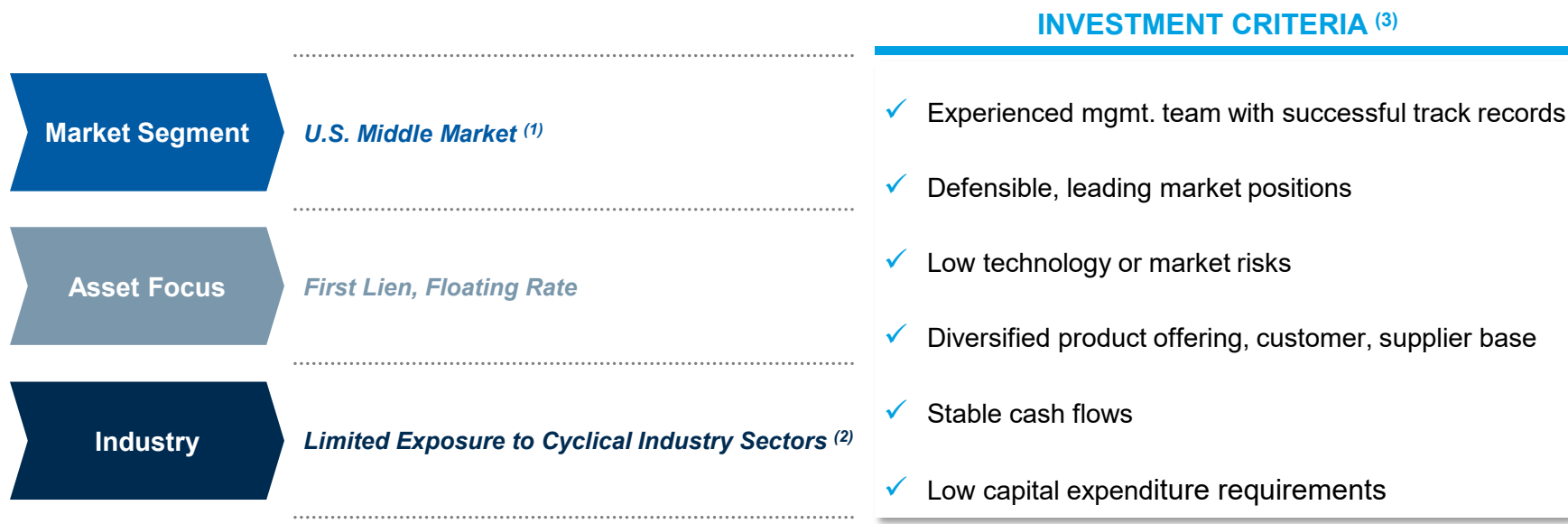

## Quarterly Highlights

### Financial Results

- Net investment income per share of \$0.66 in Q3'24, an increase from \$0.63 in Q2'24
- Earnings per share was \$0.60 in Q3'24, a decrease from \$0.66 in Q2'24
- Net asset value per share was \$20.83 as of Q3'24, flat compared to Q2'24
- Q3'24 dividends per share of \$0.60 including a \$0.50 regular dividend and a \$0.10 special dividend

### Portfolio Activity

- Total fair value was approximately \$3.6 billion, invested in 200 portfolio companies across 33 industries
  - Weighted average yield at amortized cost of debt investments was 11.0% <sup>(1)</sup>
- The Company committed \$455.4 million <sup>(2)</sup> to new investments during Q3'24, resulting in a net funded portfolio increase of \$124.1 million
  - 99% of new investment commitments were in first lien senior secured loans
  - Invested across 19 new portfolio companies
  - Received repayments on investments in 11 portfolio companies
  - Certain investments in two portfolio companies were on non-accrual status as of September 30, 2024 (0.2% of the portfolio at cost)

### Debt

- Outstanding debt balance was \$1,842.0 million, consisting of 57% unsecured debt; quarter-end debt-to-equity ratio was 0.99x
- The Company had total liquidity of \$1,191.1 million, including unrestricted cash and cash equivalents of \$88.4 million and undrawn, committed debt capacity of \$1,102.7 million <sup>(3)</sup>
- Executed an amendment to the BNP facility which extended the maturity from September 2028 to August 2029, and reduced the pricing from 2.85% to 2.25%

### Other Events

- The Board declared a regular fourth quarter dividend of \$0.50 per share, to shareholders of record as of September 30, 2024
- The Board previously declared a \$0.10 per share special dividend to shareholders of record as of November 4, 2024
- As part of the Company's share repurchase plan, 429,653 shares at an average price of \$20.06 were repurchased during the quarter ended September 30, 2024

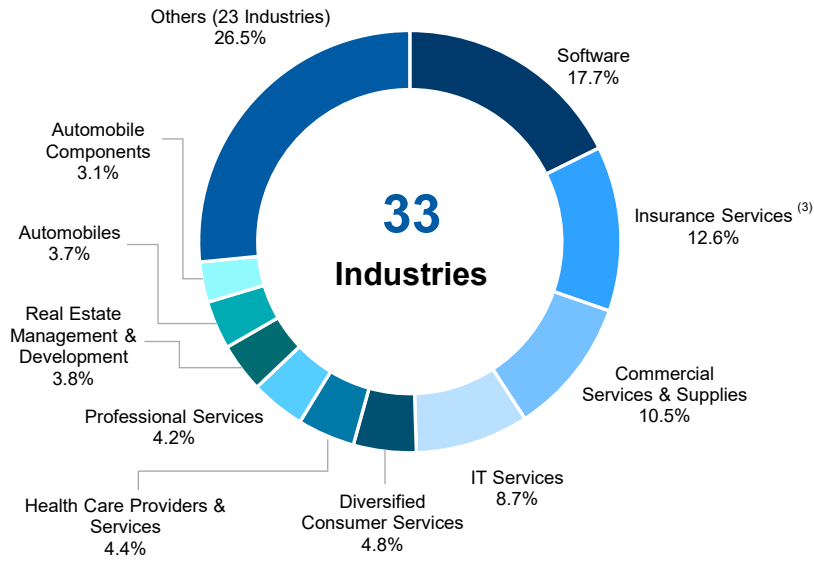

# Non-Cyclical Industries and Low Borrower Concentration

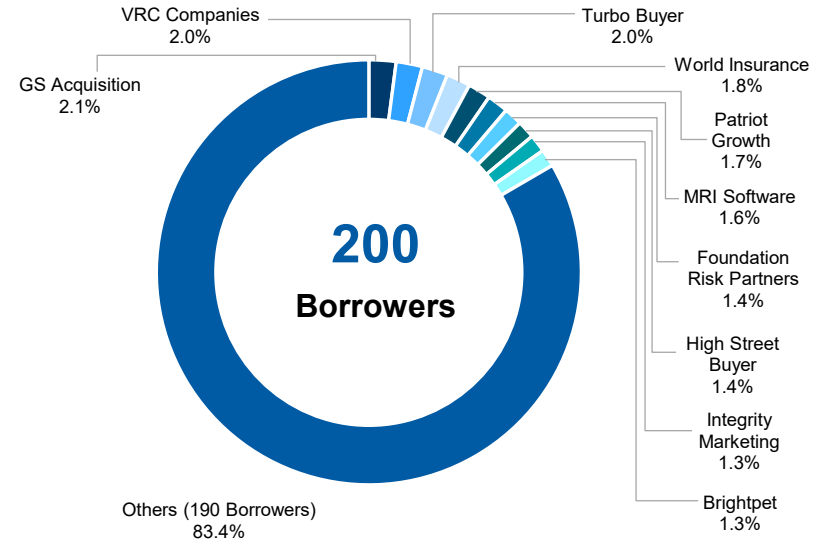
INDUSTRY CONCENTRATION <sup>(1)</sup>

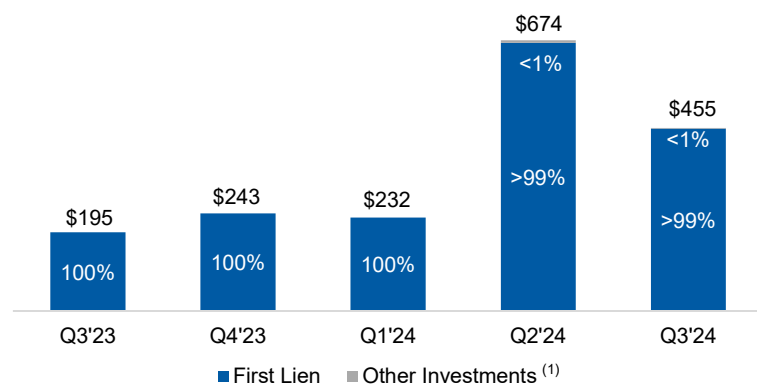

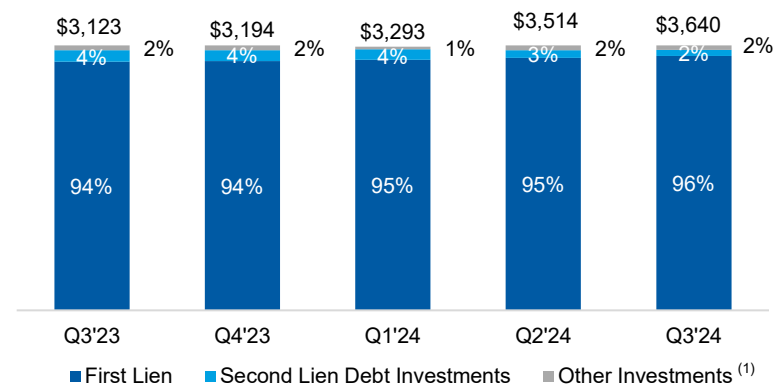
## ASSET MIX BY CAPITAL DEPLOYMENT

### Internal Risk Rating System <sup>(1)</sup>

**Risk Rating 1** In the opinion of our Investment Adviser, investments in Category 1 involve the least amount of risk relative to our initial cost basis at the time of origination or acquisition. Category 1 investments performance is above our initial underwriting expectations and the business trends and risk factors are generally favorable, which may include the performance of the portfolio company, or the likelihood of a potential exit.

**Risk Rating 2** In the opinion of our Investment Adviser, investments in Category 2 involve a level of risk relative to our initial cost basis at the time of origination or acquisition. Category 2 investments are generally performing in line with our initial underwriting expectations and risk factors to ultimately recoup the cost of our principal investment are neutral to favorable. All new originated or acquired investments are initially included in Category 2.

**Risk Rating 3** In the opinion of our Investment Adviser, investments in Category 3 indicate that the risk to our ability to recoup the initial cost basis at the time of origination or acquisition has increased materially since the origination or acquisition of the investment, such as declining financial performance and non-compliance with debt covenants; however, principal and interest payments are not more than 120 days past due.

**Risk Rating 4** In the opinion of our Investment Adviser, investments in Category 4 involve a borrower performing substantially below expectations and indicate that the loan's risk has increased substantially since origination or acquisition. Most or all of the debt covenants are out of compliance and payments are substantially delinquent. For Category 4 investments, it is anticipated that we will not recoup our initial cost basis and may realize a substantial loss of our initial cost basis at the time of origination or acquisition upon exit.

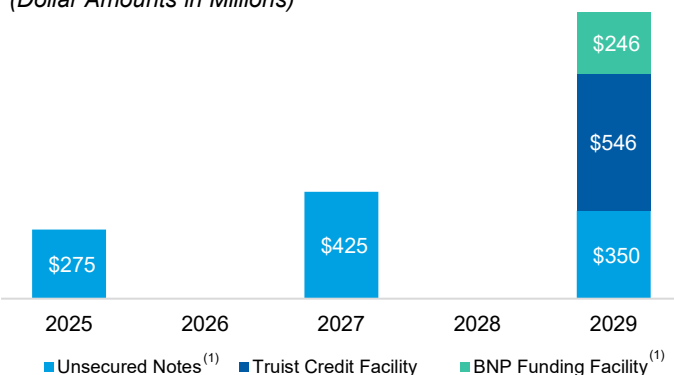

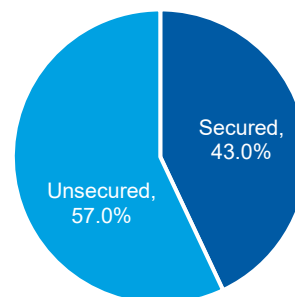

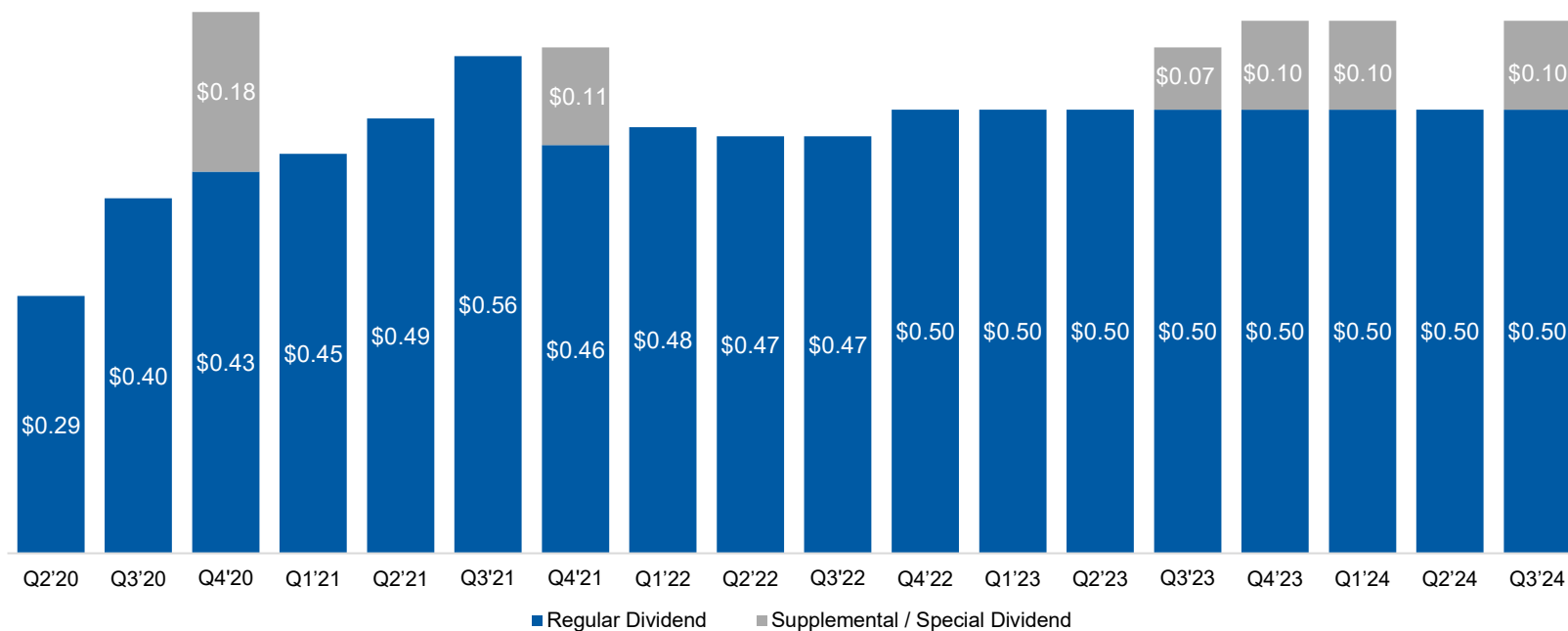
